## Consumer Financial Services Action Plan

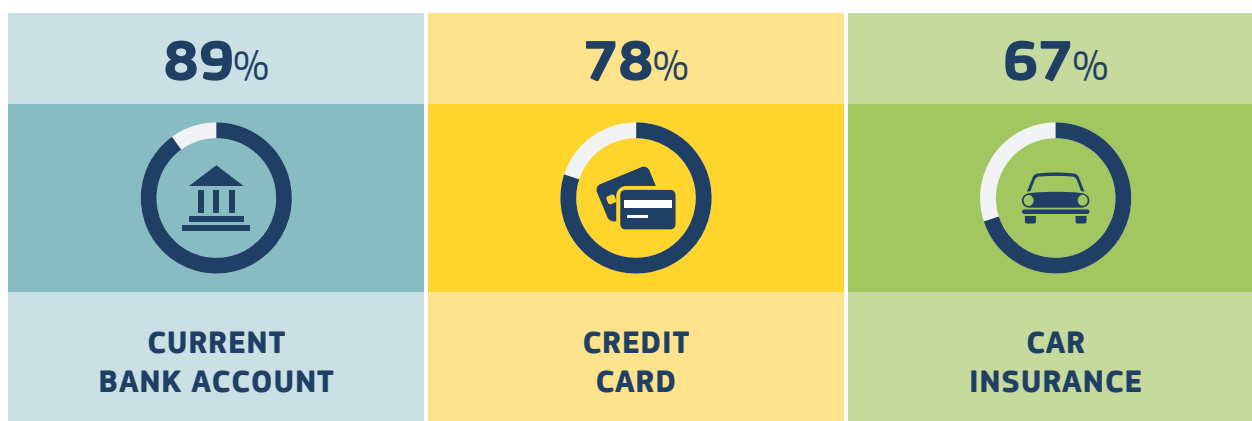

# FRANCE



Financial products and services – be they a bank account, a personal loan, insurance or an investment product – play an important role in the everyday lives of consumers in France.

The financial products and services that consumers in France (aged 15 years or older) are most likely to hold are:

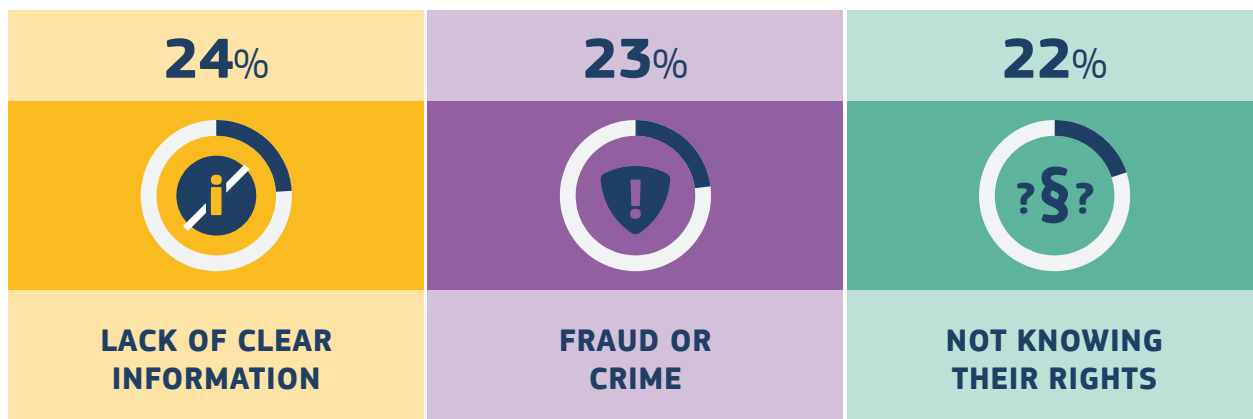


However, few French consumers purchased financial products and services in other EU countries.



Only 3% purchased at least one financial product or service elsewhere in the EU.

When purchasing financial products and services in other EU countries, French consumers are most worried about:



64% mention at least one of these or other barriers to purchasing financial products and services elsewhere in the EU.

55% simply prefer to buy their financial products and services in France.

This means that French consumers may not reap the full benefits of the single market in terms of better products, more choice and cheaper prices.

*The European Commission has therefore launched an action plan for building a deeper Single Market for consumer financial services.*
